THE CITY COUNCIL OF THE CITY OF ELIZABETHTON MET AT CITY HALL ON MONDAY, JUNE 25, 2018 AT 4:00 PM IN A SPECIAL-CALLED SESSION.

THE FOLLOWING OFFICIALS WERE PRESENT: CURT ALEXANDER, MAYOR; WILLIAM J. CARTER, MAYOR PRO-TEM; KIM BIRCHFIELD; WES FRAZIER, SAMUEL B. SHIPLEY AND JEFFREY C. TREADWAY, COUNCILMEN; ROGER G. DAY, CITY ATTORNEY; DANIEL A. ESTES, CITY MANAGER AND DEBORAH B. KESSLER, CITY CLERK.

FY 2018/19 BUDGET & PROPERTY TAX ORDINANCE  
CITY ATTORNEY DAY CAPTION READ AN ORDINANCE TO APPROVE THE FISCAL YEAR 2018/19 CITY OF ELIZABETHTON BUDGET AND PROPERTY TAX RATE.

MAYOR ALEXANDER OPENED THE MEETING FOR PUBLIC HEARING.

THERE BEING NO ONE PRESENT WISHING TO SPEAK, MAYOR ALEXANDER CLOSED THE MEETING FOR PUBLIC HEARING.

COUNCILMAN SHIPLEY REQUESTED A CHANGE TO SECTION 4 OF THE BUDGET ORDINANCE TO MOVE THE TOTAL AMOUNT OF FIFTY THOUSAND (\$50,000.00) DOLLARS FUNDED FOR CROSSWALKS ON "E" STREET TO THE SIDEWALKS FUND.

MAYOR ALEXANDER ASKED IF THERE WERE ANY FURTHER REQUESTS AND HEARING NO ONE HE ASKED FOR CITY CLERK KESSLER TO CALL ROLL ON THE ORDINANCE INCLUDING THE REQUEST BY COUNCILMAN SHIPLEY.

MOTION BY MR. SHIPLEY, SECOND BY MR. FRAZIER, APPROVING AN ORDINANCE OF THE CITY OF ELIZABETHTON, TENNESSEE ADOPTING THE ANNUAL BUDGET AND TAX RATE FOR THE FISCAL YEAR BEGINNING JULY 1, 2018 AND ENDING JUNE 30, 2019, BE PASSED ON SECOND READING.

FY 2018/19 SCHOOL BUDGET ORDINANCE

MOTION BY MR. SHIPLEY, SECOND BY MR. TREADWAY, APPROVING AN ORDINANCE ESTABLISHING THE ELIZABETHTON SCHOOL SYSTEM EXPENDITURE APPROPRIATIONS FOR THE FISCAL YEAR BEGINNING JULY 1, 2018 AND ENDING JUNE 30, 2019 BY THE ELIZABETHTON, TENNESSEE CITY COUNCIL FOR THE FISCAL YEAR 2018/2019, BE PASSED ON SECOND READING.

THE MOTION PASSED BY A VOTE OF 6-0 WITH ONE ABSENCE.
