**ELECTRICITY<sup>1</sup>**

**SECTION**

19-101. Elizabethton electric system to be operated by the city council of the City of Elizabethton.

**19-101. Elizabethton electric system to be operated by the city council of the City of Elizabethton.** Electricity shall be supplied to the City of Elizabethton and its inhabitants by a municipal electric plant established pursuant to the Municipal Electric Plant Law of 1935. The supervision and control of the maintenance and operation of the electric plant shall be by the City Council of the City of Elizabethton as set forth pursuant to the provisions of title 7, chapter 52 of the Tennessee Code Annotated. **CHAPTER 2**

**GAS**<sup>1</sup>

**SECTION**

19-201. To be furnished under franchise.

**19-201. To be furnished under franchise.** Gas service shall be furnished for the municipality and its inhabitants under such franchise as the governing body shall grant. The rights, powers, duties, and obligations of the municipality, its inhabitants, and the grantee of the franchise shall be clearly stated in the written franchise agreement which shall be binding on all parties concerned.<sup>2</sup>
